

Privacy Policy

This Privacy Policy Statement is part of the Terms and Conditions which governs your usage of our services either through the web or through mobile.

We will share Personal Information with third parties only under one or more of the following circumstances:

- If we have your consent to do so
- If your services request needs to be fulfilled by affiliates who require your personal information
- If we are compelled by law (including court orders) to do so
- If we find that your actions on our web sites violate the applicable terms of service
- If required due to suspected unlawful or illegal activities

We have put in place appropriate physical, electronic, and managerial procedures to safeguard and secure the information we collect online. However please be aware that security of internet transactions cannot be guaranteed, in spite of best of intentions.
